





s I write these lines, there is a news report that the Director-General of Uttar Pradesh Police, H.C. Awasthy, will be visiting Hathras, which is the focus of entire media in the wake of the local cops' and administration's mishandling of the alleged gang rape and murder of a 19-year-old Dalit woman. She was allegedly raped by four men of a so-called upper caste. Additional Chief Secretary (Home) Awanish Awasthi will be accompanying H.C. Awasthy. It is the first time that such senior officials would be visiting the place. Importantly, the visit comes in the wake of a snub from the Allahabad High Court. The court not only summoned senior state officials but also called the incident a matter of "immense public importance... involves allegation of high-handedness by authorities resulting in violation of basic human and fundamental rights." The Yogi Adityanath government, on its part, has tried to do some damage control. It has suspended five cops, including the Superintendent of Police concerned, from Hathras district. It has also set up a special investigative team or SIT. The Chief Minister has asserted that his government is "committed to the safety and security of women."

Even recounting the incident, which took place on September 14, is horrific. The victim, who had gone to a farm to collect cattle fodder, was ruthlessly assaulted, dragged, and allegedly raped. The doctors reportedly said that the damage to the spinal cord could be permanent. Later, she was brought to the Safdarjung Hospital in New Delhi but she succumbed to the injuries September 29. That was not the end of it; the police and the local administration cremated her body at midnight. The victim's brother told PTI: "The police have forcibly taken the body and my father along

with them for cremation. When my father reached Hathras, he was immediately taken (to the crematorium) by the police."

The more the powers that be in Uttar Pradesh and the Hathras authorities are trying to bury the case, the bigger it is becoming by the hour. On October 1, senior Congress leader Rahul Gandhi was stopped going to the village to meet the victim's family. The family, indeed the entire village, has been transformed into a containment zone—not to save it from the novel coronavirus, but to check the visits by Opposition leaders and the media. But such is the monstrosity of the act that led to the death of a young lady that even in the Bharatiya Janata Party there are rumblings against the stubborn approach of the Yogi government. In a series of tweets, senior BJP leader Uma Bharti expressed her displeasure over the issue. She asked the UP Chief Minister to let politicians and media meet the family members of the victim. "We have recently laid the foundation stone of the Ram temple and claimed to bring Ram Rajya to the country, but the suspicious action of the police has dented your image, that of @UPGovt and @BJP4India," Bharti posted on Twitter. Bharti also tweeted, "To my knowledge there is no rule that the family can't meet anyone during an investigation by an SIT (special investigation team). This will only put the SIT's investigation under a cloud."

There are many others who are angry and shocked. A former chairman of the National Human Rights Commission told me that he is disappointed that the body he once headed has done nothing to check the excesses of the UP government. I think that it is time the Centre reined in the state government and directed it to give up its obstinacy, bring the guilty to book, and penalize the officials and cops responsible for the outrage. \*\*

### Jaswant Singh: A statesman who spoke his mind

ormer Union minister and one of the founding members of the Bharatiya Janata Party (BJP), Jaswant Singh passed away on September 27 after a prolonged illness. Singh was a five-time Member of Parliament in the Rajya Sabha and had also been a member of Lok Sabha four times.

Jaswant Singh was born at Jasol village of Barmer district in Rajasthan in 1938. Educated at Mayo College in Ajmer, he later joined the Indian Army after passing out from the National Defence Academy (NDA). Quitting his position in the Central India Horse, an armored regiment, Singh went on to join politics in 1960s. He tasted success in his political career in 1980 when he was first selected for the Rajya Sabha.

In Atal Bihari Vajpayee's government, Singh held top portfolios—foreign, finance and defence. As

foreign minister, he helped to manage the national and international consequences of the nuclear tests of May 1998, which included economic and political sanctions by the US and EU, and Pakistan's retaliatory tests.

His relationship with the BJP became difficult after he did not get an election ticket in the 2014 general elections. He nonetheless contested from the Barmer constituency but lost the election. Soon after the polls, the former Union minister met with an accident in August 2014 and had remained unwell since then. He had been in and out of the hospital and was admitted on Jun 25. He was being treated for sepsis with multi-organ dysfunction syndrome and effects of severe head injury. He had a cardiac arrest on September 27. \*\*

## All you need to know about the new farming laws

The new legislations are enabling provisions, providing farmers with a choice to sell their produce without intermediaries

n the ongoing monsoon session, Parliament passed two major bills related to agriculture that has resulted in an eruption of debates and protests all over the country. Unfortunately, there is a great lack of clarity and understanding regarding the new laws themselves and the concerns of farmers. Although a state subject, the Centre seems to have taken recourse to its power under the First Schedule to regulate interstate trade and commerce to bring in these reforms.

### Which laws are in contention

The two Bills that became a hot topic of debate throughout the country were the Farmers' Produce Trade and Commerce (Promotion and Facilitation) Bill.

2020, and the Farmers (Empowerment and Protection) Agreement of Price (Assurance and Farm Services) Bill, 2020. It should also be noted that the Essential Commodities (Amendment) Bill, 2020, had already been passed.

### **Farmers' concerns**

Restricting trade practices to identified agricultural market yards has not led to fair price framework. Rather, it led to different market yard operations in different states. While one state has an elected body to supervise functioning of the yards, most other states are nominated and carry heavy administrative expenditures, establishment charges financed by the market fee. Every transaction that happens outside the yard has a fee collection at check posts. Lack of price discovery



mechanism, post-harvest facilities and legislative measures have not worked in to the farmer's advantage. The agent commission system prevalent in most markets has also not empowered them.

What seems to be agitating the minds of farmers, therefore, is the fact that the Central government is doing away with the present minimum support price (MSP) system of procurement of foodgrains. Over-dependence on middlemen, commission agents and bureaucratic controls are some of the common issues of the existing MSP system of procurement.

Although not more than 6 per cent farmers have access to the MSP-based procurement system, it is a highly balanced system. In addition to the MSP, the Centre pays 6 per cent as market fee and another 2.5 per cent as agent commission in some states like Punjab, incurring approximately Rs 3,000 crore annually.

This indicates that certain states where maximum agricultural procurement is done benefit from a rent-seeking system at no added value. The government tries to convince farmers that the new laws would ease deregulation of agricultural markets, increase their incomes by opening by private investment in the sector and benefit them. Broadly, farmers demand that the mandi system stays, their loans are cleared, a law is put in place that guarantees payment from the buyers through middlemen, and that banks do not deduct money in the name of loan recovery.

### **Trade Areas**

Definition of the Trade Areas is "as any area or location, place of production, collection, and aggregation including (a) farm gates; (b) factory premises; (c) warehouses; (d) silos; (e) cold storages; or (f) any other structures or places, from where the trade of farmers' produce may be undertaken in the territory of India."

The definition does not, however, include "the premises, enclosures, and structures constituting (i) physical boundaries of principal market yards, sub-market yards, and market sub-

yards managed and run by the market committees formed under each state APMC (Agricultural Produce Market Committee) Act."

In effect, the existing mandis established under APMC Acts have been excluded from the definition of trade area under the new legislation.

The protesters say this provision will confine APMC mandis to their physical boundaries and give a free hand to big corporate buyers.

Notably, the APMC system was abolished in Bihar in the year 2006, which has resulted in increased participation from the private sector. Consequently, the farmers have also benefitted.

### **Traders**

According to the Ministry of the Agriculture and Farmers' Welfare, "Any trader with a PAN card can buy the farmers' produce in the trade area."

As per the new legislation, a trader can operate in both an APMC mandi and a trade area. However, for trading in the mandi, the trader would require a license/registration as provided for in the State APMC Act. In the present mandi system, Arhatiyas (commission agents) have to get a license to trade in a mandi.

The protesters say Arhatiyas have credibility as their financial status is verified during the license approval process. But it will not be easy for a farmer to trust a trader under the new law. But it is also true that the registered companies are, by default, more credible.

This also explains why the protests have mostly been concentrated in Punjab and Haryana. The Arhatiya system is more prevalent in these two states than in other states.

### **Market fees**

Section 6 states that "no market fee or cess or levy, by whatever name called, under any State APMC Act or any other State law, shall be levied on any farmer or trader or electronic trading and transaction platform for trade and commerce in scheduled farmers' produces in a trade area."

This provision will reduce the income of the State and will benefit both the farmers and the traders. The capital that used to go to the state would now go to the farmers.

### Dispute resolution mechanism

According to the section 8, in case of a dispute arising out of a transaction between a farmer and a trader, the parties may seek a mutually acceptable solution through conciliation by filing an application to the sub-divisional magistrate or SDM.

The protesters, however, fear that the proposed system of conciliation can be misused against them as the ordinance does not allow farmers to approach a civil court.

### What the government says

According to the government, the private sector's investment and other amendments in legislations will bring significant positive changes in the agriculture sector. Also, the government maintained that the farmers will continue to receive MSP despite these amendments and there will be no change in mandis established under the state laws.

### The way forward

While the new laws seem to be in the favor of the farmers, there are certain things that we need to keep in mind:

- \* Farming contractors or their associates should not be allowed to purchase the farmer's land. There shall be a restricted provision on it because section 8 of the Act is not sufficient.
- \* Farming contracts/agreements drafting must be in the local language of that area so that the farmers can understand the terms of contract.
- \* There should be a farmers' association on every district level and the association should be part of the dispute resolution authority.
- \* Mandi and MSP must be continued as it is being another options to farmers.
- \* In case of any dispute government should provide legal help to farmers free of cost.
- \* Government shall provide farming contract/agreement terms draft on each and every language.
- \* Recovery proceedings should be strictly up to the farm crops only and not against the farmers' personal assets/land/house/bank account. Government recovery agencies should not arrest farmers.
- \* Farmers allowed to use Kisan credit cards even after farming contracts.
- \* Inter/intra state toll tax/road tax should not be applicable on farmers.

### **Conclusion**

There are no easy answers to support any one view. Federation of All India Farmer's Association believes that the new farm laws ensure sustainable, profitable future for farming community. The Centre feels that crucial steps it has taken envisioning a fair market for farmers will help them, empowering them to be in control of the prices of their produce. These laws are enabling provisions, providing farmers with a choice to sell their produce without intermediaries. The new laws will discourage monopolization of their produce by large-scale buyers, hoarders, and corporations. \*\*



Prime Minister Narendra Modi, who turned 70 on September 17, has had an eventful life which has hugely impacted the nation



arendra Damodar Das Modi's story is too wellknown to be recounted in our cover story. Yet, we do that to highlight the importance of the man who has redefined Indian politics

as well as politicking, the politician who just a couple of decades ago was known to only Bharatiya Janata Party leaders and a handful of political journalists, the icon who is both loved and loathed with an equal intensity.

Born on September 17, 1950, into a Gujarati family in Vadnagar, Narendra Modi's early years were very difficult. "The family belonged to the marginalized sections of society and had to struggle to make ends meet," says narendramodi.in. "The entire family lived in a small single storey house (approximately 40 feet by 12 feet). His father sold tea at the tea stall he set up in the local railway station. In his early years, Narendra Modi too lent a hand to his father at the tea stall."







While his detractors have accused Modi of being biased against Muslims, there is no evidence to suggest that he harbored animosity towards them. As a child he often celebrated both Hindu and Muslim festivals, according to narendramodi.in.



These years left an abiding mark on him. As a child, he "balanced his studies, non-academic life and his contribution at the family tea stall. His schoolmates recall Narendra as a diligent student with a penchant for debating and reading. He would spend hours and hours reading in the school library. Among the sports, he was very fond of swimming."

While his detractors have accused Modi of being biased against Muslims, there is no evidence to suggest that he harbored animosity towards them. "As a child he often celebrated both Hindu and Muslim festivals considering the large number of Muslim friends he had in the neighborhood," according to narendramodi.in.

Modi reportedly dreamt of serving in the Army but it couldn't be realized, for his family was against the idea. "Narendra Modi was very keen to study in Sainik School located in nearby Jamnagar but when the time came to pay the fees, there was no money at home."

So, the course of his life took a different turn. "He wanted to go out there and make a difference to society... to wipe tears and suffering among people. At a young age, he developed an inclination towards renunciation and asceticism. He gave up eating salt, chilies, oil and jaggery. Reading the works of Swami Vivekananda cover to cover took Narendra Modi to a journey of spiritualism and laid the foundation for his own mission to fulfill Swami Vivekananda's dream of a Jagad Guru Bharat," says narendramodi.in.

At the age of eight, he joined the Rashtriya Swayamsewak Sangh (RSS). He set up a unit of the RSS' students' wing, the Akhil Bharatiya Vidyarthi Parishad, in his area. There he met Lakshmanrao Inamdar, popularly known as Vakil







Saheb, who later became his political mentor. Modi rose steadily in the RSS hierarchy, and his association with the organization significantly benefited his subsequent political career.

While Modi was training with the RSS, he also met Vasant Gajendragadkar and Nathalal Jaghda, Bhartiya Jana Sangh leaders who became founding members of the Bharatiya Janata Party's Gujarat unit in 1980.

During the political crisis of the mid-1970s, prime minister Indira Gandhi declared a state of Emergency, banning political organizations such as the RSS. Modi went underground and wrote a book, Sangharsh ma Gujarat (Gujarat in Emergency), which chronicles his experiences as a political fugitive.

He graduated from Delhi University with a degree in political science in 1978, and completed his master's work at Gujarat University in 1983. Modi became

an RSS sambhag pracharak (regional organizer) in 1978, overseeing RSS activities in the areas of Surat and Vadodra, and in 1979 he went to work for the RSS in Delhi, where he was put to work researching and writing the RSS's version of the history of the Emergency.

Modi joined the BJP in 1987, and a year later he was made the general secretary of the Gujarat branch of the party. He was instrumental in greatly strengthening the party's presence in the state in succeeding years. Modi rose within the party

and was named a member of the BJP's National Election Committee in 1990, helping organize L.K. Advani's Ram Rath Yatra in 1990 and Murli Manohar Joshi's 1991-92 Ekta Yatra (Journey for Unity).


However, he decided to take a brief break from politics in 1992. He established a school in Ahmedabad. He had a fight with Shankersingh Vaghela, a BJP MP from Gujarat at the time; this also played a part in this decision. Modi returned to electoral politics in 1994, partly at the insistence of Advani, and as party secretary, Modi's electoral strategy was considered central to the BJP victory in the 1995 state assembly elections. His rise through the ranks was rapid, as he wisely chose mentors to further his career. He favored privatization of businesses and small government, and promoted Hindu values.

In October 2001 he replaced the incumbent Gujarat chief minister, fellow

BJP member Keshubhai Patel, after Patel was held responsible for the state government's poor response to the massive Bhuj Earthquake in the state earlier that year that had killed more than 20,000 people. Modi entered his first-ever electoral contest in a February 2002 by-election that won him a seat in the Gujarat state Assembly.

In February 2002, while Modi serving as chief minister of Gujarat, a train was attacked allegedly by radicalized Muslims. Violence began in retaliation, and it spread like wildfire. Modi

imposed a curfew, granting police shoot-to-kill orders. After peace was restored, the Modi government was criticized for not stopping the riots in which more than 1,000 Muslims died. His administration and police were blamed for being unable and unwilling to check the killings of Muslims.

Quite apart from political allegations, he was also legally challenged. Most of it happened when the Congress was in power (2004-14). The Supreme Court, however, found no evidence against Modi.

Politically too, Modi went from strength to strength, getting elected as chief minister of Gujarat in 2002, 2007, and 2012—and then as Prime Minister, in 2014 and again in 2019. In fact, it was Modi's repeated political success in Gujarat that made him an indispensable leader within the BJP.

After a vigorous campaign—in which Modi portrayed himself as a pragmatic candidate capable of turning around India's economy, while his critics portrayed him as a controversial and divisive figure—he and the party were victorious.

Modi was sworn in as Prime Minister on May 26, 2014. Since then, Modi has encouraged foreign businesses to invest in India. He has lifted various regulations—permits and inspections—so that businesses could grow more easily. Under him, India has climbed steeply in the World Bank's Ease of Doing Business ranking.

In 2014, he launched a "Clean India" campaign, which focused on sanitation and the construction of millions of toilets in rural areas. In terms of foreign policy, Modi has taken on a multilateral approach.

He has participated in the BRICS, Asean and G20 summits, and has aligned himself with the United States, Japan, and Australia to improve economic and political ties.


In 2016, Modi won the reader's poll as TIME's Person of the Year. In previous years, he had received top ranking as one of the most influential political figures in the world in both TIME and Forbes Magazine.

It has been more than six years since Narendra Modi has been India's Prime Minister. His tenure has been full of surprises, some of which the result of controversial decisions. While Modi has attempted to improve efficiency in the bureaucracy, he has also been accused of centralizing power by, among other things, abolishing the Planning Commission.

He began a high-profile sanitation campaign and initiated a controversial demonetization of high-denomination banknotes. The demonetization policy drew a lot of flak for its unpleasant consequences for peasants, petty traders, micro, small and medium enterprises or MSMEs, and laborers. Former prime minister Manmohan Singh highlighted its deleterious effect on economic growth and development.

Eight months after demonetization came the goods and services tax (GST). The one-step rollout of the GST created panic in the businesses. Though GST largely eased the burden of taxation, business owners, particularly, the smaller ones, complained about the cumbersome process of tax filing, making the biggest indirect tax reform an impediment in business.

On national defence and security, however, the Modi regime has fared better. On September 29, 2016, the Indian Army announced that it had conducted a surgical strike on terror launch-pads in Pakistan-occupied Kashmir. The media claimed that up to 50 terrorists and Pakistani soldiers had been killed in the strike. Against the Pulwama outrage too, the Modi government's response—Indian Air Force aircraft entering the

Pakistani air space for the first time after 1971—was robust.

Following BJP's victory in the 2019 General Elections, his administration revoked the special status of Jammu and Kashmir. His administration also introduced the Citizenship Amendment Act, which resulted in widespread protests across the country.

The Modi government's recent move—three new farm laws—is a bold move which has the potential of revolutionizing agriculture. It is unfortunate that Opposition leaders, vested interests, and ill-informed farmer leaders are opposing the three laws which empower the farmer to sell his produce to his choice of buyers anywhere.







Indeed the strength of a government lies in the efficacy of it policies in taking development challenges head-on and resolving them. And health is one of the major issues that have negatively and hugely impacted earlier poverty alleviation and development programmes. A look at a few sets of data clarifies the point here. The per capita expenditure on health care has increased from Rs 61 in 2009-10 to Rs 1,677 in 2017-18! If we factor in healthcare inflation at 7 per cent, we can well imagine the galloping cost of household healthcare expenditure and its consequent impact at the lowest strata of the economic pyramid.

The government has remained concerned about it.

In 14.4 per cent of households, the annual expenditure on healthcare exceeds per capita overall expenditure. The situation is dire. On the other hand, given the tough battle that the government had to fight to meet its budgetary allocation for so many other sectors, it couldn't find enough resources to address the issues of health care. The National Health Profile 2019 admitted that spending 1.28 per cent of the GDP on healthcare was not enough to meet the demand.

In this context, the Pradhan Mantri Jan Arogya Yojana, popularly referred to as Ayushman Bharat scheme, must rate as a policy masterstroke to address the issues related to healthcare that have remained the bane of development efforts. Aimed at the poor, covering nearly 50 crore people, it provides healthcare coverage of Rs 5 lakh per family per year.

The strategy here is simple. Instead of focusing on creating physical infrastructure,




### which takes time, it gives the poor immediate access to the existing infrastructure by providing them with medical insurance. Put into effect in September 2018, the scheme should merit as one of the jewels of this government led by the Honorable Prime Minister Narendra Modi. This scheme unshackles the poor from the compulsion of out-of-pocket expenditure in medical emergencies, frees them from the compulsion of spending while already bankrupt and selling whatever asset they have, to meet the cost.

The other jewel is the Atmanirbhar Bharat. While healthcare cost has tended to undermine the poverty alleviation programmes, lack of continued employment generation mechanism has hamstrung attempts to give the poor an adequate income. The failed attempts to break the vicious cycle of poverty and create the virtuous cycle of prosperity and well-being have been blamed on policy-makers' failure to be innovative. With this programme, the analysts are seeing a new positive direction in creating jobs.

Atmanirbhar Bharat focuses on providing greater ease of market play for

micro, small and medium enterprises or MSMEs. Keeping in mind that this sector is the largest employment generator in the country, stressing on self-reliance, efficiency and equity and with such a long rope given to MSMEs, a quick turnaround is foretold and the lost jobs will be regained as soon as the demand starts picking up.

### Power forridors Initiative

What needs to be noted here is that the Atmanirbhar Bharat programme focuses on ease of doing business. The government has taken note of the fact that MSMEs cannot raise or deploy resources as easily as a large unit can. Similarly, market access is relatively more difficult for this sector. Yet, this is the sector that creates the greatest chunk of employment, also having a substantial contribution to the export earnings of the country. The nimbleness in addressing market needs is also a great trait of this sector. It would be relevant to remember in this context that this was the sector that turned us from a country that hardly made any personal protective equipment or PPE to one that now manufactures enough for local demand and exports.

Other interesting figures can be read with such successes. Most of the jobs created in the last three years were by MSMEs. And of all the jobs created, more than 70 per cent were in the micro-units.

Realizing the potential of this sector, the Atmanirbhar Bharat paves the path for MSMEs towards opportunity by creating access to both market and funds. MSMEs are now expected to ramp up production and create further net employment. This, in other words, is an answer to the curse of unemployment.

On this note, it might be worth mentioning that, with government support, microfinance will also have an important role to play. The new-unemployed, with little or no capital to invest, need finance to start a business. Microfinance institutions (MFIs), with their experience in the sector, already have the core processes and may be the key facilitators for these self-employed. The fact that MFIs don't just provide credit but also train their customers in the productive use of money will be a great differentiator in the journey.

These two projects together could yield the solution to the poverty alleviation question. While the first takes care of the healthcare needs of the poor, the other seeks to generate employment and thereby put them on the prosperity cycle.

This is the reason why I am optimistic and look forward to a healthy country with economic independence in its truest sense. \*



## Modi Govt begins new green revolution

The new laws have the potential of revolutionizing agriculture and dramatically increasing the incomes of farmers, but a politically-motivated and ill-informed agitation is creating problems



t is saddening to see so much resistance to the Narendra Modi government's move to introduce reforms in agriculture and emancipate the farmer from the clutches of vested interests. The silver lining is that the powers that be are not in a mood to bow to the opposition to the new farm laws.

The Bharatiya Janata Party's oldest allies, the Akalis, have parted ways; a number of political and thought leaders are up in arms against the new farm laws; and in various parts of the country farmers are agitating against the new, liberalized regime of trading and storing of agricultural produce.

A few weeks earlier, Union minister Harsimrat Badal had quit the cabinet, protesting against the government decision to bring three liberalizing ordinances which later were cleared by Parliament. The proposed ordinances intended to undo some of the most regressive socialist era laws, free the farmer from hoarding regulations, and

give him the choice to sell to the buyers who pay him the best price.

The new laws have the potential of revolutionizing agriculture and dramatically increasing the incomes of farmers. In no way the three new laws could be construed as anti-farmer. These are enabling provisions, not debilitating measures. Resistance to them is politics pure and simple; indeed it is dirty politics.

The three ordinances were the Farmers Produce Trade and Commerce (Promotion and Facilitation) Ordinance, 2020, the Farmers (Empowerment and Protection) Agreement; and the Essential Commodities (Amendment) Ordinance, 2020.

Harsimrat Badal tweeted later, "I have resigned from Union Cabinet in protest against anti-farmer ordinances and legislation. Proud to stand with farmers as their daughter & sister."

But the ordinances, as we mentioned earlier, were not anti-farmer; protests against them are, rooted in politics and stupidity. In fact, her party, Shiromani Akali Dal, had been supporting the ordinances till a month before her resignation; its position changed 180 degrees when a stir, organized by doctrinaire and ill-informed activists, gathered momentum.

"Farm Bills clearing Lok Sabha is a historic moment for the farmers in the country and the agricultural sector. These Bills, in true sense, will eliminate bottlenecks and middlemen," Prime Minister Narendra Modi tweeted in Hindi. He also rightly said in a tweet, "A lot of people are trying to mislead the farmers. I want to assure my brothers that MSP and government purchase will continue. These bills, in true sense, are meant to empower the farmers."

Bharatiya Janata Party president J.P. Nadda also resolutely defended the new laws. "First, peasants were in slavery. Prime Minister Modi gave a call to liberate farmers. This Bill gives them the freedom to choose whether the farmer sells his crop in mandi or sells it in any corner of the country," said Nadda.

Political rhetoric apart, the BJP chief's statement is not without merit. The extant

laws practically tie down agriculturists to the mandis and the rich middlemen running them.

Nadda also raised an important point: "The Congress party had said in its manifesto that we will bring the farmers out from APMC, the Essential Commodities Act has rusted, we will change it. Modiji has shown the way today by doing it."

The opponents of the proposed agricultural rules are also being economical with the truth when they say that the minimum support price (MSP) is being done away with. The Modi government has flatly denied this charge. Further, no decision has been taken to end MSPs; there is not even a move in that direction.

But the Opposition propaganda continues. For instance, senior Congress leader and former finance minister P. Chidambaram wrote in The Indian Express (September 27) that "what the Modi government has done is to weaken the safety net (of MSP) and dilute public procurement. Farmers are protesting on the streets because they fear that the MSP will be done away with. State governments are worried that Public Procurement and PDS will be jeopardized. Once the three pillars of food security are undermined, the food security system that is being created under the National Food Security Act, 2013, will collapse."

Further, Chidambaram wrote, "The Modi government's laws do not create thousands of alternative markets. Instead, they will allow contract farming and open the door for the entry of corporates and, eventually, cartels."

But Mr. Chidambaram, didn't you too wanted to do the same thing? Economic Survey 2012-13, for example, said, "In order to bring about reforms in the [organized marketing] sector, a model Agricultural Produce Marketing (Development and Regulation) (APMC) Act was prepared in 2003. Though the process of market reforms has been initiated by different state governments through amendments in the present APMC Act on the lines of Model Act, many of the states are yet to adopt the Model Act uniformly. It is therefore necessary to complete the process of market reforms early in order to provide farmers an alternative competitive marketing channel for transaction of their agricultural produce at remunerative prices. Development of an agricultural marketing infrastructure is the foremost requirement for the growth of a comprehensive and integrated agricultural marketing system in the country."

The Modi government has done which none of its predecessors could do, though the experts advising them wanted to liberalize the farm sector.

## Wrinkling Out old age

### A little bit of care and balanced diet will keep wrinkles away from your face

his article is all about what are wrinkles, what causes them, and what increases their appearance. It also looks at some methods that people use to reduce wrinkles.

first wrinkles tend to appear on a person's face, in areas where the skin naturally folds during facial expressions. - 4) Beta carotene and retinol (vitamin A) are often ingredients in the cosmetic anti-wrinkle creams but it's not necessary to buy a product to get access to beta carotene. Eating a balanced diet is the best way to get any micronutrients like beta carotene (vitamin A) which is found amply in dark leafy greens such as kale and spinach, sweet potatoes, broccoli, peas, carrots, and Roman lettuce (you can add a little oil to help the body absorb the nutrients);
- 5) Applying a topical gel containing vitamin C can help improve the appearance of wrinkles and other signs of sun damage on the skin;

# How to live happily was

Epictetus (55-c.135) was a Greek philosopher belonging to the school of Stoicism. He was a slave who later became free. Though he wrote nothing, his pupil Arrian compiled his teachings. Influenced by Socrates and Diogenes, his main interest was in ethics. Epictetus saw philosophy as learning "how it is possible to employ desire and aversion without hindrance." There are things which are under our control, and those which are not; the latter are directed by God. We should try to focus on the things like the will, and all voluntary actions—that is, the things in our own power. For the rest, we should not torment our minds and hearts, for they are under God's control. This is the Stoic attitude. Excerpts from Epictetus' writings:

he same general principles are common to all men, nor does one such principle contradict another. For which of us does not admit that good is advantageous and eligible, and in all cases to be pursued and followed? Who does not admit that justice is fair and becoming? Where, then, arises the dispute? In adapting these principles to particular cases. As, when one cries, "Such a person has acted well; he is a gallant man"; and another, "No; he has acted like a fool." Hence arises dispute among men. This is the dispute between Jews, and Syrians, and Egyptians, and Romans; not whether the right be preferable to all things, and in every instance to be sought; but whether the eating swine's flesh be consistent with right, or not. This, too, you will find to

have been the dispute between Achilles and Agamemnon. For call them forth. What say you, Agamemnon. Ought not that to be done, which is fit and right? — "Yes, surely." — Achilles, what say you? Is it not agreeable to you, that what is right should be done? — "Yes; I desire it beyond everything." Apply your principles then. Here begins the dispute. One says, "It is not fit that I should restore Chryseis to her father." The other says, "Yes; but it is." One or the other of them, certainly, makes a wrong conception of the principle of fitness. Again, the one says: "If it be fit that I should give up Chryseis, it is fit, too, that I should take some of your prizes." The other answers, [65] "What, that you should take my mistress?" — "Ay; yours." — "What, mine only? Must I only, then, lose my prize?"

What then is it to be properly educated? To learn how to apply the principles of natural right to particular cases, and, for the rest, to distinguish that some things are in our power, while others are not. In our own power are the will, and all voluntary actions; out of our power, the body and its parts, property, parents, brothers, children, country; and, in short, all our fellow-beings. Where, then, shall we place good? In what shall we define it to consist? In things within our own power. "But are not health, and strength, and life, good? And are not children, parents, country? You talk unreasonably."

Let us, then, try another point of view. Can he who suffers evil, and is disappointed of good, be happy? He cannot. And can he preserve a right behavior with regard to society? How is it possible that he should? For I am naturally led to seek my own highest good. If, therefore, it is my highest good to have an estate, it is for my good likewise to take it away from my neighbor. If it is my highest good to have a suit of clothes, it is for my good likewise to steal it wherever I find it. Hence wars, seditions, tyranny, unjust invasions. How shall I, if this be the case, be able, any longer, to do my duty towards Zeus? If I suffer evil, and am disappointed, he takes no care of me. And, what is he to me, if he cannot help me; or, again, what is he to me, if he chooses I should be in the condition that I am? Then I begin to hate him. What, then, do we build temples, do we raise statues, to Zeus, as to evil demons, as to the goddess Fever? How then is he the preserver; and how the dispenser of rain and plenty? If we place the essence of good on any such

ground, all this will follow. What, then, shall we do?

This is the inquiry which interests him who philosophizes in earnest, and to some result. Do I not now see what is good, and what is evil, or am I mad? Suppose I place good only in things dependent on my own will? Why, everyone will laugh at me. Some gray-headed old fellow will come, with his fingers covered with gold rings, and will shake his head, and say; "Hark ye, child, it is fit you should learn philosophy; but it is fit, too, you should have commonsense. All this is nonsense. You learn syllogisms from philosophers; but how you are to act, you know better than they." Then, what displeases you if I do know? What can I say to this unfortunate? If I make no answer, he will burst; so I must answer thus: "Bear with me, as with lovers. Granted; I am not myself. I have lost my senses."

#### **Against Epicurus**

Even Epicurus is sensible that we are by nature sociable beings; but having once placed our good in the mere outward shell, he can say nothing afterwards inconsistent with that. For again, he strenuously maintains, that we ought not to admire, or accept, anything separated from the nature of good. And he is in the right to maintain it. But how, then, arise any affectionate anxieties, unless there be such a thing as natural affection towards our offspring? Then why do you, Epicurus, dissuade a wise man from bringing up children? Why are you afraid, that, upon their account, he may fall into anxieties? Does he fall into any for a mouse, that feeds within his house? What is it to him, if a little mouse bewails itself there? But Epicurus knew that if once a child is born, it is no longer in our power not to love and be solicitous for it. On the same grounds he says that a wise man will not engage himself in public business, knowing very well what must follow. If men are only so many flies, why should he not engage in it?

And does he, who knows all this, dare to forbid us to bring up children?

Not even a sheep, or a wolf, deserts its offspring; and shall man? What would you have? That we should be as silly as sheep? Yet even these do not desert their offspring. Or as savage as wolves? Neither do these desert them. Pray, who would mind you, if he saw his child fallen upon the ground and crying? For my part, I am of opinion, that your father and mother, even if they could have foreseen that you would have been the author of such doctrines, would not have thrown you away.

### How we ought to struggle with difficulties

Difficulties are things that show what men are. For the future, in case of any difficulty, remember, that God, like a gymnastic trainer, has pitted you against a rough antagonist. For what end? That you may be an Olympic conqueror; and this cannot be without toil. No man, in my opinion, has a more profitable difficulty on his hands than you have; provided you will but use it, as an athletic champion uses his antagonist.

Suppose we were to send you as a scout to Rome. But no one ever sends a timorous scout, who, when he only hears a noise, or sees a shadow, runs back frightened, and says, "The enemy is at hand." So now, if you should come and tell us: "Things are in a fearful way at Rome; death is terrible, banishment terrible, calumny terrible, poverty terrible; run, good people, the enemy is at hand"; — we will answer: Get you gone, and prophesy for yourself; our only fault is, that we have sent such a scout.

Diogenes was sent a scout before you, but he told us other tidings. He says that death is no evil, for it is nothing base; that calumny is only the noise of madmen. And what account did this spy give us of pain, of pleasure, of poverty? He says, that to be naked is better than a purple robe; to sleep upon the bare ground, the softest bed; and gives a proof of all he says by his own courage, tranquility, and

freedom; and, moreover, by a healthy and robust body. "There is no enemy near," he says. "All is profound peace." How so, Diogenes? "Look upon me," he says. "Am I hurt? Am I wounded? Have I run away from any one?" This is a scout worth having. But you come, and tell us one thing after another. Go back and look more carefully, and without fear.

"What shall I do, then?"

What do you do when you come out of a ship? Do you take away with you the rudder, or the oars? What do you take, then? Your own, your bundle and your flask. So, in the present case, if you will but remember what is your own, you will not covet what belongs to others. If some tyrant bids you put off your consular robe? "Well, I am in my equestrian robe." Put off that too. "I have only my coat." Put off that too. "Well, I am naked." I am not yet satisfied. "Then e'en take my whole body. If I can throw off a paltry body, am I any longer afraid of a tyrant?"

"But such a one will not leave me his heir." What, then, have I forgotten, that such things are never really mine? How then do we call them ours? As with a bed, in an inn. If the landlord, when he dies, leaves you the bed, well and good; but if to another, it will be his, and you will seek one elsewhere; and, consequently, if you do not find one, you will sleep



upon the ground; only sleep fearlessly and profoundly, and remember, that tragedies find their theme among the rich, and kings, and tyrants. No poor man fills any other place in one, than as part of the chorus; whereas kings begin, indeed, with prosperity: "Crown the palace"; — but continue about the third and fourth act: "Alas, Citheron! Why didst thou receive me!" Where are thy crowns, wretch; where is thy diadem? Cannot thy guards help thee?

Whenever you are brought into any such society, think then that you meet a tragic actor, or rather, not an actor, but Œdipus himself. "But such a one is happy. He walks with a numerous train." Well; I too walk with a numerous train.

But remember the principal thing; that the door is open. Do not be more fearful than children; but as they, when the play does not please them, say, "I will play no longer"; so do you, in the same case, say, "I will play no longer"; and go; but, if you stay, do not complain.



#### I betray where I am vulnerable

If these things are true; and if we are not stupid, or insincere, when we say, that the good or ill of man lies within his own will, and that all beside is nothing to us; why are we still troubled? Why do we still fear? What truly concerns us is in no one's power: what is in the power of others concerns not us. What embarrassment have we left?...

Moreover, some are peevish and fastidious, and say, I cannot dine with such a fellow, to be obliged to hear him all day recounting how he fought in Mysia. "I told you, my friend, how I gained the eminence." There I begin to

suffer another siege. But another says, "I had rather get a dinner, and hear him prate as much as he pleases."

Do you decide between these opinions; but do not let it be with depression and anxiety, and the assumption that you are miserable; for no one compels you to that. Is there smoke in my house? If it be moderate, I will stay; if very great, I will go out. For you must always remember, and hold to this, that the door is open. "You are forbidden to live at Nicopolis." I will not live there. "Nor at Athens." Well, nor at Athens. "Nor at Rome." Nor at Rome. "But you shall live at Gyaros." I will live there. But suppose that living at Gyaros seems to me like living in a great smoke. I can then retire where no one can forbid me to live, for it is an abode open to all; and put off my last garment, this

poor body of mine; beyond this, no one has any power over me.

Thus Demetrius said to Nero: "You sentence me to death; and Nature you." If I prize my body first, I have surrendered myself as a slave; if my estate, the same; for I at once betray where I am vulnerable. Just as when a reptile pulls in his head, I bid you strike that part of him which he guards; and be you assured, that wherever you show a desire to guard yourself, there your master will attack you. Remember but this, and whom will you any longer flatter or fear?

"But I want to sit where the senators do."

Do not you see, that by this you incommode and torment yourself?

"Why, how else shall I see the show in the Amphitheatre advantageously?"

Do not insist on seeing it, O man! and you will not be incommoded. Why do you vex yourself? Or wait a little while; and when the show is over, go sit in the senators' places, and sun yourself. For remember, that this holds universally; we incommode and torment ourselves: that is, our own preconceived notions do it for us. What is it to be reviled, for instance? Stand by a stone, and revile it; and what will you get by it? If you, therefore, would listen only as a stone, what would your reviler gain? But, if the reviler has the weakness of the reviled for a vantage-ground, then he carries his point.

"Strip him," [bids the tyrant]. What mean you by him? Take my clothes, strip them, at your pleasure. "I meant only to insult you." Much good may it do you.

These things were the study of Socrates; and, by these means, he always preserved the same countenance. Yet we had rather exercise and study anything, than how to become unrestrained and free. "But the philosophers talk paradoxes." And are there not paradoxes in other arts? What is more paradoxical than to prick anyone's eye that he may see? Should one tell this to one ignorant of surgery, would not he laugh at him? What wonder then if, in philosophy also, many truths appear paradoxes to the ignorant? \*

tweets make "disputed claims on coronavirus."

A few hundred years ago, the claims about the spherical shape of the earth were also "disputed." In more recent times, the findings of S. Chandrasekhar, the Nobel laureate of Indian origin, were also disputed by top authorities; the findings included what later came to be known as the Chandrasekhar Limit. A leading English astronomer, Sir Arthur Eddington, called young researcher's "mathematical game playing."

Thankfully, there was no Twitter in the days of Copernicus, Galileo, Chandrasekhar, and other great scientists; otherwise, they too would have become the victims of the 'cancel culture' and 'de-platforming' that the radical Left is promoting and Bolshevik billionaires are enforcing.

Like the medieval church, with its claims of infallibility, the contemporary tech tyrants are convinced that they are divinely ordained to know the truth. ## The press under a free government

US President Donald Trump has many a time denounced the mainstream media as "fake news"—not incorrectly, given the pathological hatred against Trump the likes of CNN and The New York Times have exhibited. But there was a time, about a century ago, when the press was doing a good job. One of Trump's predecessors, Calvin Coolidge (1923–29) addressed the American Society of Newspaper Editors Washington, on January 17, 1925, underlined the importance of free press. We publish the speech




he relationship between governments and the press has always been recognized as a matter of large importance. Wherever despotism abounds, the sources of public information are the first to be brought under its control. Wherever the cause of liberty is making its way,

one of its highest accomplishments is the guarantee of the freedom of the press. It has always been realized, sometimes instinctively, oftentimes expressly, that truth and freedom are inseparable.

An absolutism could never rest upon anything, save a perverted and distorted view of human relationships and upon false standards set up and maintained by force. It has always found it necessary to attempt to dominate the entire field of education and instruction. It has thrived on ignorance. While it has sought to train the minds of a few, it has been largely with the purpose of attempting to give them a superior facility for misleading the many. Men have been educated under absolutism, not that they might bear witness to the truth, but that they might be the more ingenious advocates and defenders of false standards and hollow pretenses. This has always been the method of privilege, the method of class and caste, the method of master and slave.

When a community has sufficiently advanced so that its government begins to take on that of the nature of a republic, the processes of education become even more important, but the method is necessarily reversed. It is all the more necessary under a system of free government that the people should be enlightened, that they should be correctly informed, than it is under an absolute government that they should be ignorant. Under a republic, the institutions of learning, while bound by the constitution and laws, are in no way subservient to the government. The principles which they enunciate do not depend for their authority upon whether they square with the wish of the ruling dynasty, but whether they square with the everlasting truth. Under these conditions the press, which had before been made an instrument for concealing or perverting the facts, must be made an instrument for their true representation and their sound and logical interpretation. From the position of a mere organ, constantly bound to servitude, public prints rise to a dignity, not only of independence, but of a great educational and enlightening factor. They attain new powers, which it is almost impossible to measure, and become charged with commensurate responsibilities.

Propaganda seeks to present a part of the facts, to distort their relations, and to force conclusions which could not be drawn from a complete and candid survey of all the facts. has become one of the dangers of the present day.

The great difficulty in combating unfair propaganda, or even in recognizing it, arises from the fact that

at the present time we confront so many new and technical problems that it is an enormous task to keep ourselves accurately informed concerning them. In this respect, you gentlemen of the press face the same perplexities that are encountered by legislators and government administrators. Whoever deals with current public questions is compelled to rely greatly upon the information and judgments of experts and specialists.

Unfortunately, not all experts are to be trusted as entirely disinterested. Not all specialists are completely without guile. In our increasing dependence on specialized authority, we tend to become easier victims for the propagandists, and need to cultivate sedulously the habit of the open mind. No doubt every generation feels that its problems are the most intricate and baffling that have ever been presented for solution. But with all recognition of the disposition to exaggerate in this respect, I think we can fairly say that our times in all their social and economic aspects are more complex than any past period. We need to keep our minds free from prejudice and bias. Of education, and of real information we cannot get too much. But of propaganda, which is tainted or perverted information, we cannot have too little.

Newspaper men, therefore, endlessly discuss the question of what is news. I judge that they will go on discussing it as long as there are newspapers. It has seemed to me that quite obviously the news giving function of a newspaper cannot possibly require that it give a photographic presentation of everything that happens in the community. That is an obvious impossibility.


It seems fair to say that the proper presentation of the news bears about the same relation to the whole field of happenings that a painting does to a photograph. The photograph might give the more accurate presentation of details, but in doing so it might sacrifice the opportunity the more clearly to delineate character. My college professor was wont to tell us a good many years ago that if a painting of a tree was only the exact representation of the original, so that it looked just like the tree, there would be no reason for making it; we might as well look at the tree itself. But the painting, if it is of the right sort, gives something that neither a photograph nor a view of the tree conveys. It emphasizes something of character, quality, individuality. We are not lost in looking at thorns and defects; we catch a vision of the grandeur and beauty of a king of the forest.

And so I have conceived that the news, properly presented, should be a sort of cross section of the character of current human experience. It should delineate character, quality, tendencies and implications. In this way the reporter exercises his genius. Out of the current events he does not make a drab and sordid story, but rather an in forming and enlightened epic. His work becomes no longer imitative, but rises to an original art.

Our American newspapers serve a double purpose. They bring knowledge

doubt if those adjustments are any more difficult than have to be made in every other department of human effort. Life is a long succession of compromises and adjustments, and it may be doubted whether the press is compelled to make them more frequently than others do.

When I have contemplated these adjustments of business and editorial policy, it has always seemed to me that American newspapers are peculiarly representative of the practical idealism of our country. Quite recently, the construction of a revenue statute resulted in giving publicity to some highly interesting facts about incomes. It must have been observed that nearly all the newspapers published these interesting facts in their news columns,



while very many of them protested in their editorial columns that such publicity was a bad policy. Yet this was not inconsistent. I am referring to the incident by way of illustrating what I just said about the newspapers representing the practical idealism of America. As practical newsmen they printed the facts. As editorial idealists they protested that there ought to be no such facts available.

Some people feel concerned about the commercialism of the press. They note that great newspapers are great business enterprises earning large

profits and controlled by men of wealth. So they fear that in such control the press may tend to support the private interests of those who own the papers, rather than the general interest of the whole people. It seems to me, however, that the real test is not whether the newspapers are controlled by men of wealth, but whether they are sincerely trying to serve the public interests. There will be little occasion for worry about who owns a newspaper, so long as its attitudes on public questions are such as to promote the general

welfare. A press which is actuated by the purpose of genuine usefulness to the public interest can never be too strong financially, so long as its strength is used for the support of popular government.


There does not seem to be cause for alarm in the dual relationship of the press to the public, whereby it is on one side a purveyor of information and opinion and on the other side a purely business enterprise. Rather, it is probable that a press which maintains an intimate touch with the business currents of the nation is likely to be more reliable than it would be if it were a stranger to these influences. After all, the chief business of the American people is business. They are profoundly concerned with producing, buying, selling, investing and prospering in the world. I am strongly of opinion that the great majority of people will always find these are moving impulses of our life. The opposite view was oracularly and poetically set forth in those lines of Goldsmith which everybody repeats, but few really believe: Ill fares the land, to hastening ills a prey,/Where wealth accumulates, and men decay.

Excellent poetry, but not a good working philosophy. Goldsmith would have been right, if, in fact, the accumulation of wealth meant the decay of men. It is rare indeed that the men who are accumulating wealth decay. It is only when they cease production, when accumulation stops, that an irreparable decay begins. Wealth is the product of industry, ambition, character and untiring effort. In all experience, the accumulation of wealth means the multiplication of schools, the increase of knowledge, the dissemination of intelligence, the encouragement of science, the broadening of outlook, the expansion of liberties, the widening of

Of course, the accumulation of wealth cannot be justified as the chief end of existence. But we are compelled to recognize it as a means to well-nigh every desirable achievement. So long as wealth is made the means and not

the end, we need not greatly fear it. And there never was a time when wealth was so generally regarded as a means, or so little regarded as an end, as today. Just a little time ago we read in your newspapers that two leaders of American business, whose efforts at accumulation had been most astonishingly successful, had given fifty or sixty million dollars as endowments to educational works. That was real news. It was characteristic of our American experience with men of large resources. They use their power to serve, not themselves and their own families, but the public. I feel sure that the coming generations, which will benefit by those endowments, will not be easily convinced that they have suffered greatly because of these particular accumulations of wealth.

So, there is little cause for the fear that our journalism, merely because it is prosperous, is likely to betray us. But it calls for additional effort to avoid even the appearance of the evil of selfishness. In every worthy profession, of course, there will always be a minority who will appeal to the baser instinct. There always have been, and probably always will be, some who will feel that their own temporary interest may be furthered by betraying the interest of others. But these are becoming constantly a less numerous and less potential element in the community. Their influence, whatever it may seem at a particular moment, is always ephemeral. They will not long interfere with the progress of the race which is determined to go its own forward and upward way. They may at times somewhat retard and delay its progress, but in the end their opposition will be overcome. They have no permanent effect. They accomplish no permanent result. The race is not traveling in that direction. The power of the spirit always prevails over the power of the flesh. These furnish us no justification for interfering with the freedom of the press, because all freedom, though it may sometime tend toward excesses, bears within it those

remedies which will finally effect a cure for its own disorders.

American newspapers have seemed to me to be particularly representative of this practical idealism of our people. Therefore, I feel secure in saying that they are the best newspapers in the world. I believe that they print more real news and more reliable and

characteristic news than any other newspaper. I believe their editorial opinions are less colored in influence by mere partisanship or selfish interest than are those of any other country. Moreover, I believe that our American press is more independent, more reliable and less partisan today than at any other time in its history. I believe this of our press, precisely as I believe it of those who manage our public affairs. Both are cleaner, finer, less influenced by improper considerations than ever before. Whoever disagrees with this judgment must take the chance of marking himself as ignorant of conditions which notoriously affected our public life, thoughts and methods, even within the memory of many men who are still among us.

It can safely be assumed that selfinterest will always place sufficient emphasis on the business side of newspapers, so that they do not need any outside encouragement for that part of their activities. Important, however, as this factor is, it is not the main element which appeals to the American people. It is only those who do not understand our people, who believe that our national life is entirely absorbed by material motives. We make no concealment of the fact that we want wealth, but there are many other things that we want very much more. We want peace and honor, and that charity which is so strong an element of all civilization. The chief ideal of the American people is idealism.

I cannot repeat too often that America is a nation of idealists. That is the only motive to which they ever give any strong and lasting reaction. No newspaper can be a success which fails to appeal to that element of our national life. It is in this direction that the public press can lend its strongest support to our government. I could not truly criticize the vast importance of the counting room, but my ultimate faith I would place in the high idealism of the editorial room of the American newspaper. \*\*

# PLin Gulf: Will it come out clean?

Organizing IPL in the Gulf, and that too without proper measures to check sharp practice, is a very bad decision that BCCI took



ndian Premier League 2020 in the Gulf may be a gift for Cricket-crazy expats in region but is a boon for those who are on dark side of the game. It is a paradise for match-fixing; it got chance by default as Covid-19 pandemic forced the BCCI to move away from India. For match fixers and those involved in other malpractices, no situation could be better than this one. It's not a statement but true feeling of every cricket lover. This could have been avoided.

#### 2 superovers in first 10 days?

IPL 2020 was scheduled between September 19 and November 10 in Abu Dhabi, Dubai and Sharjah. The very first match of IPL 2020, played between Mumbai Indians (MI) and Chennai Super Kings (CSK) has raised many eyebrows. In first 10 days, there have been two superover matches. As many as 60 T20 matches will be played in IPL 2020. Will there be more superovers?

#### **Matches in Epicentre**

Fixers and bookies operate simply and smoothly to make it big in the IPL. When it comes to the United Arab Emirates (UAE), a known epicentre for match-fixing and other



corrupt practices, buying a cricketer is not difficult for bookies. The Indian government used to consider the UAE an unholy place for cricket; it was averse to sending its national team over there. Why this change of heart?

#### **UAE's dirty past**

This time around, no objections were raised when the BCCI, under former cricket captain Sourav Ganguly and secretary Jay Shah, decided to take the Indian Premier League to the UAE, which was viewed as the best venue to host the multi-million dollar event during the ongoing pandemic.

Over the last 10 months, the ICC has banned six UAE international cricketers for their involvement in match-fixing. In September alone, the international cricketing body punished two UAE players—Ashfaq Ahmed and Aamir Hayat—for accepting large cash and expensive gifts from fixers. According to an ICC investigation report, Ashfaq and Hayat had UAE Dirhams 15,000 (about Rs 300,623) each from a known corrupter in exchange of fixing aspects of an international match. So, when the IPL is already underway, a big question arises: will the shadow of corruption and match-fixing reach the tournament?

#### Dhoni's snail pace raise eyebrow

Chennai Super Kings captain M.S. Dhoni's way of playing and some unexpected turns in the game have occasioned many questions. Interestingly, the BCCI will not be availing the services of the ICC's anti-corruption and security unit for this IPL; the partnership was dissolved last year, reportedly

over cost concerns. It means

has reported that the
board's position "raised

a few eyebrows" over what many saw as effectively putting a price tag on the fight against corruption and ensuring the integrity of the sport.

#### **Sports integrity at risk!**

This time, the BCCI's own anti-corruption and security unit, headed by Ajit Singh, will be on the job. As international mafia and betting syndicates reportedly have a huge presence in the UAE, it may be a tough task for the board to keep their glamorous tournament corruption-free. "There are nearly 80 foreign players involved from across the world along with Bollywood stars, their staff and supporters. No one is saying that there is corruption in the IPL; we are confident that there isn't. But are they doing enough to keep it that way?" a media report said, quoting an anonymous state cricketing association official. The BCCI has inked an agreement with Sportradar, a sports integrity solutions and sports data products company, to support the board's anti-corruption unit in monitoring and checking the integrity of matches during the IPL this season.

#### Chor bana kotwal!

This decision is the BCCI's biggest folly, for the involvement of Sportradar is a potential case of conflict interest as the entity and its parent company, Betradar, provides services to bookmakers across the world. It means the BCCI has appointed a body with questionable credentials to check corruption! According to the Sportradar website, "We provide all the necessary services to run a bookmaker operation, such as pre-match odds services, live odds and live data services, risk & liability management

services, betting stimulation tools (including statistics and live scores), live streaming services, innovative gaming solutions and e-sports betting services." \*\*
